Friends who voted are attending members. The rates go up by \$5 after the conclusion of Westercon 66, and the new convention's website will be westercon68.org. Ron Oakes made a accumulator predictions correction to the flyer that was handed out: rates on that flyer are good from 7/8/13 through 12/31/13.

Ms. June Moffatt thanked the convention for not considering the Stardust Hotel.
